AHTCA COMMITTEE MEETING – 24/5/2022

AGENDA

Matters discussed were as follows and agreement was unanimous unless stated otherwise:

• Opening

The meeting was conducted via Zoom hook-up and was opened by Mr Jervis Ward, who welcomed all members present to the Committee meeting.

Apologies were read out and noted.

• Committee positions

- The attendees agreed to vote in new positions.
- Following a unanimous vote, the following positions were agreed:
 - Chair Mr Jervis Ward;
 - Vice chair Martin Dennis;
 - Secretary/Treasurer Mr Nic van den Berg.

Eligibility

Signage, names and numbers

- The Committee also noted the rules in the Motorsport Australia <u>Specifications of Automobiles -5th Category Historic Cars Vehicle Eligibility General Requirements</u>
- The Committee noted the existing Motorsport Australia application form "Paintwork and Signage 5th Category".

1.3 PAINTWORK AND SIGNAGE:

The original style of paintwork and livery is encouraged. Tobacco advertising signage in accord with that carried during the historic group period will, however, be acceptable only on privately owned vehicles where the owner certifies that no direct or indirect benefit is received from any party in consideration for the carriage of such signage. This certification must be provided prior to the issue of any Certificate of Description evidencing the display of such signage.

- (a) The name of the driver may be shown on the vehicle, appearing once on either side in a position below the window line, in a size not larger than 40mm by 300mm.
- (b) A club badge, of an acceptable motoring club, can appear on the vehicle. Each badge must be not larger than 150mm by 100mm and must be placed below the window line. Only two such badges are permitted, one on each side of the vehicle.
- (c) The territory of origin of the driver may be shown on the vehicle. Each sign must be not larger than 100mm by 150mm and must be placed below the window line. Only two such signs are permitted, one on each side of the vehicle.
- (d) No other advertising material or sign is permitted unless evident in the applicable group period (see relevant Group Articles) or, upon application by an Organiser or an individual club or competitor group subject to the prior approval of any affected organiser/s. Specific approval by the Australian Historic Motor Sport Committee is required to allow the display of event sponsor signage. Applications should be submitted well in advance of the event/s in question (a period of at least six weeks is envisaged) and be supported by full details of the event/s, the specific signage proposed and the benefits to be derived by competitors and/or organisers. If approved, the positioning of such signage on the various Groups of historic vehicles will be determined by the Committee, having regard to vehicle type and historic precedent. Dimensions of any such signage must be in accordance with the restrictions set out in FIA Appendix K.

1.4 COMPETITION NUMBERS:

Competition numbers carried by 5th Category vehicles must comply with the requirements of Schedule K, article 2 (refer "General Requirements for Cars and Drivers") except as follows:

- (a) Groups J, K, L, Sa and Na are exempted from the requirements as to background specified in Schedule K, article 2.3.
- (b) All 5th Category vehicles which have a disc or rectangular background to the competition number may carry either black numbers on a white background or white numbers on a black background.
 - Applications for exemption from the requirements as to background specified in Schedule K (refer "General Requirements for Cars and Drivers") and/or for the carriage of numbers differing in typestyle, size, colour or placement to the normal requirements may be made in individual cases where the specified vehicle competed in such a visual form during the relevant group period. Approvals to such applications will be evidenced by inclusion in the logbook and Certificate of Description of photographs showing the approved style of competition number on the car.
- (c) Group N vehicles may use a windscreen competition number. The number must be white, bold sans serif condensed (Helvetica Bold Condensed, Zurich Bold Condensed or Arial Narrow Bold) and 100mm high. And should be located no more than 120mm from the top of the windscreen to the top of the number on the passenger side of the front windscreen.
- Mr Ward advised that the correct fonts are to be used and a reminder will be issued via EDM.
- Agreed that we need to remind competitors to have approved signage on their vehicles for the approved event do so via EDM.

Tyre Approval process

➤ The Committee noted the existing rule to add a new tyre, in the Motorsport Australia Manual Specification of Automobiles – 5th Category – Groups N&S – Approved Tyre List at paragraph 1.2:

- (f) An application to add a new tyre to the approved list must be made to the HPBEC and shall include the following information:
 - Manufacturer's information sheets showing tyre make and model identification.
 - (ii) Tyre dimensions (overall diameter, section width and recommended rim widths).
 - (iii) Illustrations of the tread pattern.
 - (iv) Section sizes available in the model range.
 - (v) Where the tyre is produced in multiple compounds the range and the method of identification must be provided.
 - (vi) Any other relevant information that would be required in identifying the tyre at an eligibility check.
- Nankang tyre was the matter for discussion. These tyres are not on the approved list. Mr Dennis's objective is to have them on the list and he will work towards obtaining the above information to have them approved.
- Mr Ward to obtain clarification as to what compound type is open.

The following updates were discussed and noted

- Specification sheets new
 - Alfa Romeo Giulia Super.

AHTCA agreed that the draft Specification sheet should be agreed and referred to the Chair of HPBEC for approval and subsequent publication.

➤ Holden FE/FC.

Holden FE specification has been updated to include Holden FC and wheel size for both models has been updated to 6"

Ford Cortina Mark 2- 220,240, 440

This vehicle was missed when Specification sheets were developed and the Chair of HPBEC requested it be completed.

- Specification sheets existing updates
 - Ford Cortina GT Mark 2

Now includes Type 2 Single Rail and Type 3 single rail gearboxes

Datsun 1600

The model of differential (R180) has been found by MA to be incorrect and it is to be updated following examination and approval by the Chair of HPBEC.

- MA Manual 2020 Motorsport Manual Specifications of Automobiles 5th Category Historic Cars – Group A, C, N, & U – Touring Cars
 - Brakes cooling ducts

The document has been updated to include the following words:

Front and Rear Brake cooling ducts may be fitted. Front ducts to a maximum width of 300mm on each side vehicle. If brake cooling ducts or scoops are fitted, they must be separated by a minimum of 300mm so as not to form an aerodynamic aid and their sole function shall be to assist in the supply of air to the brakes. Any Rear brake ducting must be wholly contained within the perimeter of the bodywork

Group Nb – bodywork - wording

There is presently no wording in the Group Nb section of this document dealing with Mudguards/flares and extensions. MA has agreed that this has been omitted in error and is to be addressed by including the same wording in the Group Nb section that is in the Group Nc section of the document:

Bodywork: Mudguard flares/extensions – flares and/or extensions to the guards are not permitted unless originally fitted to the make and model in question by the manufacturer. The inner lip of the wheel opening may be folded back for tyre clearance.

Competition numbers - Group Na

The reference at paragraph 1.4 (a) is out of date and MA has agreed it will be updated to refer to Para 3(b) of the MA Motorsport Manual Technical Appendix – Schedule K – Markings on Automobile.
