## AGENDA

Matters discussed were as follows and agreement was unanimous unless stated otherwise:

## • Opening

The meeting was conducted via Zoom hook-up and was opened by Mr Jervis Ward, who welcomed all members present to the Committee meeting and mentioned his happiness with the operation of AHTCA and the reflection by HPBEC of our current operation.

## Eligibility

- Approved Tyre list
  - The Committee members agreed that the review of the current tyre list continues and subsequently reports to HPBEC, as many listed tyres are no longer available. AHTCA wants to work towards a more timely and proactive approach to tyre changes, keeping in mind that past approved tyres remain as approved.
  - Information provided by Bill McKenna on 25 October 2022 as shown in the Secretary report for 14 November 2022.
  - A note is to be completed by the Secretary and then discussed by AHTCA prior to referral to HPBEC.

## The following were noted:

- MA Manual 2020 Motorsport Manual Specifications of Automobiles 5th Category Historic Cars Group A, C, N, & U Touring Cars

  - The result from HPBEC is now awaited.
- Minimum weights
  - The suggested one-page information sheet from AHTCA to the Chair of HPBEC was issued on 2 November 2022 (Attachment B in the Secretary's report for 14 November 2022).

## AHTCA Website

### Establishment costs

The Committee noted progress as reported in the Secretary's report, and the issuance of the note to proceed which was issued to iDesign on 28 October 2022 (Attachment E in the Secretary's report for 14 November 2022).

### Annual running costs of \$1,440.

 $\circ$  Mr Jervis Ward is to advise the Secretary further on the sponsorship for these costs.

## **AHTCA Constitution**

The Committee noted that before the end of 2022, the AHTCA constitution is to be lodged with amendments covering the following:

- State based representation
- Duality of State based Clubs

With regard to the situation in Queensland, the Committee noted that a note was issued on 14 November 2022 to all QLD Group N competitors. A special meeting will be held based in a week's time (22 November 2022) to discuss the outcome.

Results are to be collected and collated by the Secretary of the AHTCA and advised to the AHTCA Committee.

#### **National Calendar**

The HTCA NSW President wrote to Jervis Ward and advised that HTCAV President had promoted a national calendar, but the matter had gone quiet. It was agreed that the AHTCA will take this up and all members agreed to provide dates as soon as they can so that the national calendar can be placed on the new AHTCA website.

The AHTCA will then work on a national marketing and promotion plan for the national calendar.

#### General Business

The Committee noted the issuance on 7 November 2022 by AHTCA of a note from Dean Bryant, Eligibility Officer – Group N and S.O.D.P. Technical Delegate Motorsport Australia (Attachment A).

Mark Blyfield suggested that AHTCA undertakes a collection of the number of Group N cars within each State and make a register, so that AHTCA can locate vehicles that are registered as Group N vehicles, but no longer compete. Nic van den Berg is to ask Motorsport Australia to assist in this regard.

The results of this concept could then be publicised on the AHTCA website, linking that to the Kingcott database. Matin Dennis advised that he holds a copy of that database and he will forward it to the Secretary of the AHTCA this purpose. It was agreed that this database will be examined and its contents will be assessed for suitability for the Group N cars databases on the AHTCA website. The Committee also agreed that nothing will be published outside the AHTCA and without permission of AHTCA.

The next meeting of the AHTCA will be a Committee meeting, and will be held on 17 January 2023.

# Following on from recent race meetings it has come to my attention that the process surrounding our rev limiter rules, are possibly being abused by some competitors and teams.

The rules are in place to produce a fairer field of play for all.

As a Motorsport Australia Eligibility officer and Technical Delegate, I have always held the view that when transgressions are discovered we need to also consider if there has been genuine error, accident or simple mistakes involved prior to exercising our powers regarding infringement notices and their subsequent penalties. The benefit of doubt is always considered.

This open mindedness and fairness of process may have been taken advantage of, and with that in mind I now advise all competitors of the solution – as follows;

Prior to Qualifying and racing, rev limiter chips and units (where required to be fitted) may all be tested by our Eligibility team as per Motorsport Australia regulations (see below).

# Where your spec sheet states the requirement for the use of a MSD Soft Touch rev limiter Part No 8728 with a 7500 RPM limit.

- The limiter will be subject to testing at race meetings.
- The limiter will be located in an easily accessible position within the engine bay.

If your spec sheets says a limiter is required, it must strictly comply with the regulation above. If it does not you need to ensure it does prior to inspection at the track – you have been warned.

Any rev limiter chip found to be tampered with in any way during a race event, will incur the issue of an infringement notice.

As per the general regulations the subsequent actions and penalties applied will be decided by the stewards.

'Oh my chip must have fallen out' – it's the competitors responsibility to ensure it doesn't!

'The seal must have just come off' – if you didn't notice that prior to the session and advise us to recheck it then once again it was the competitor's responsibility!

'I didn't know I had to move the limiter' see above! It's your responsibility!

It seems to me that it is possible the rules and boundaries are being tested by some competitors and teams, the current rules in place allow us a mechanism to ensure this cannot be the case in the future and we will now avail ourselves of this mechanism.

Given the fact this information will be distributed to all group N competitors in Australia via the AHTCA and the state clubs, it is clear that our decision to implement this practice without leniency is warranted, sound and just.

The Victorian Eligibility team for group N has agreed to operate this system where possible and we encourage all interstate eligibility teams to consider the same practice. Should an interstate competitor anywhere assume that the excuse for non-compliance is that it is not enforced elsewhere, you may well be very disappointed.



At the recent Historic Sandown event Victorian EOs trialled the Parc Ferme' system.

Future events may, where possible, include Parc Ferme' conditions for all competitors at the conclusion of each session.

The details of the Parc Ferme' conditions will be relayed to each competitor via the new tower to car one-way radio system at each session as well as be included in the Supp. Regs for the event.

Each competitor has a responsibility to comply with these conditions or infringement notices and possible subsequent penalties will be applied.

In short, cars will assemble in the stated Parc Ferme' location for a stated time period. Tyre pressures may be checked and engines started for cooling purposes, but that is all!

Any unauthorised interaction with the car by driver or crew prior to release of the cars from Parc Ferme' may result in an infringement notice.
