AGENDA

Matters discussed were as follows and agreement was unanimous unless stated otherwise:

Opening

The meeting was conducted via Zoom hook-up and was opened by Mr Jervis Ward, who welcomed all members present to the Annual General meeting.

Secretary/Treasurer Report

The Secretary/Treasurer Report was noted.

Eligibility

The Committee noted updates provided in the Secretary's Report relating to Specification Sheets and Reference Sheets.

EO Forum

The Committee noted that the EO forum that was held on 12 April 2023 was successful and that further monthly meetings will occur.

AHTCA Website

The Committee noted that the Chat room for Technical Delegates and Eligibility Officers was set up in the AHTCA website on 18 April 2023.

The Committee agreed that the AHTCA website be actively promoted in every eDM, so as to encourage its use as the primary information source from Group N.

Mail Chimp

The Committee agreed to an annual subscription for Mailchimp.

Minimum Weights

The Committee noted the delivery of a weights list by Mr David Twigg on 17 April 2023 to the Chair and the Secretary for 82% of all currently listed Group N cars.

The Committee agreed to:

- The development and approval by AHTCA by 19 April 2023 of a one-page information sheet;
- Subsequent approval of the one-page information sheet by Messrs Adamson and Twigg
- The publication of the list received on the AHTCA website once the one-pager has been approved by Messrs Adamson and Twigg.

The Committee agreed that AHTCA representatives will be the central point of any comments about minimum weights and will collect and centralise that feedback, and in that way, present a national view about any feedback.

The Committee noted:

- its disappointment that Mr David Twigg had also issued the note to Eligibility Officers on 17 April 2023, a fact which was not provided to AHTCA, and which came to light following contact to AHTCA on 18 April 2023 by three Eligibility Officers;
- that this disjointed and unadvised activity had, on 18 April 2023, by the AHTCA Secretary, been raised directly with Messrs Twigg and then discussed with Mr Frank Adamson.

Control Tyres

The Committee noted that the survey about this topic has now been completed and full results are to be provided by Mr Ward.

The Committee agreed that sufficient responses had been received to warrant further effort being put in by AHTCA further developing the concept of control tyres.

Motorsport Australia

The Committee agreed that a letter be prepared and circulated for prior approval by all AHTCA members, that letter providing the CEO of Motorsport Australia with a status report of progress on matters brought to his attention in the AHTCA Chair's letter of 23 January 2033 and his response of 6 February 2023.

General Business

5 Year plan

The Committee agreed that in coming months, AHTCA members turn our attention to:

Developing a five-year plan for the AHTCA's activities with and for Historic Touring Cars, that plan including maters such as:

- as vehicles age and original parts become harder to source, proactive attention to developing a list of suitable substitute components through our own research, so as to be ready for a Component Substitution application to the HPBEC;
- as costs for components, vehicle preparation and event entry fees increase, researching
 and developing alternative solutions to attracting sponsorship for our category, including,
 but not restricted to markings on motor vehicles.

Bonnet latches

Mr Ron Blake raised the matter of bonnet latches and advised that QLD EOs had requested that AHTCA publish the correct interpretation of regulations about bonnet latches.

The Committee agreed that this matter would be referred to the EO forum for attention at its next meeting.


Chimpmail subscription

MA Administration

Discussion paper 1 was circulated on 15 January 2022 and led to the letter to the CEO of Motorsport Australia and his response on 6 February 2023.

A reminder was issued to Motorsport Australia on 6 April 2023 about the following commitments from the CEO of Motorsport Australia on 6 April 2023:

AHTCA ISSUES 3.4 AND 5

We will ensure that the membership of the Committee will be published on our website next week and that an explanation of the role of the Committee and of the HPBEC is also published.

AHTCA ISSUE 6

The makeup of the HPBEC is a HMC decision and we have scheduled a meeting for 1st March for the HMC to review the membership of the HPBEC.

AHTCA ISSUE 7

Meetings of the HMC and HPBEC are recorded and minuted however, these are not required to be published. There are matters discussed that may not be concluded which are best not published due to the need for confidentiality while a matter or issue is being considered. We will consider providing an abridged or summary version of the minutes to only cover matters that can be placed in the public domain.

AHTCA ISSUES 11 AND 12

EO Forum conducted on 12 April 2023 (see further information in this report) – MA was advised on 6 April 2023 that:

Chair of the HPBEC is not the boss of Eligibility Officers - see the MA website - the Chair of the HPBEC has the following responsibilities:

The HPBEC shall be responsible for provision of advice to the HMC regarding:

The current state of eligibility of historic production-based vehicles competing in historic motorsport in Australia; and

Rules, policies and procedures to enable the effective ongoing management of historic production-based vehicle eligibility.

AHTCA ISSUE 13

AHTCA wrote to the Chair of the HPBEC (David Twigg) on 15 February 2023 and advised that:

Competitors are awaiting the publication of the list of weights, and the AHTCA believes that this step will lead to contest about the proposed starting weights for particular vehicle types. In order to continue to manage this matter in an efficient and timely manner, AHTCA now awaits your early advice as to when the AHTCA will be provided with the list of wet weights that HPBEC proposes to use as the starting point. AHTCA requests same so that AHTCA can, as the one-page advised, "publish the proposed weights to Group N Clubs and competitors" as soon as possible.

We have heard nothing from David Twigg - we do not know where he is up to with this weights list, who is involved in it, or when and how they are to be published. All we have heard is that David Twigg informally advised some Mini competitors what the starting weights for their vehicle types will be.

The President of HTCAV wrote to MA on 2 April 2023 about the operation of Eligibility Officers at Philip Island.

David Twigg advised the EO Forum on 12 April 2023 that the target date for completion of the list is June 2023. He was again offered assistance from AHTCA at this meeting to have this task completed.




