AGENDA

Matters discussed were as follows and agreement was unanimous unless stated otherwise:

Opening

The meeting was conducted via Zoom hook-up and was opened by Mr Jervis Ward, who welcomed all members present to the Annual General meeting.

Secretary/Treasurer Report

The Secretary/Treasurer Report was noted.

2022 Annual Statement

The Members noted the lodgement of the 2022 Annual Statement as appearing in these Minutes with Consumer Affairs Victoria on 9 May 2022.

Eligibility

The Members noted updates provided in the Secretary's Report relating to Specification Sheets and Reference Sheets.

The Members also noted further updates to Specification Sheets and Reference Sheets as follows:

- Ford Mustang 1968
- Ford Mustang Boss 302
- Ford Galaxie Nc
- Ford Galaxie Nb

Bonnet latches

Members noted that;

- HTCAV issued advice to their members about bonnet latches on 5 May 2023, that advice being issued following clarification on the matter by a Gold Scrutineer;
- This advice was issued on the same date by Mr Nic van den Berg in his capacity as the Secretary of the EO Forum to all EOs;
- Mr Bruce Richards (QLD) responded on the same date advising: I agree with the "Gold Scrutineer " as it is probably correct for the contemporary categories, however the rules for Group N (5th Category) states that all body attachments must remain except that the pin and spring can be removed so the bonnet can be opened from the outside of the car. In my opinion the bonnet safety hook (which is the secondary catch for a standard mechanism) should remain as part of the bodywork .Group N rules also state that all original fixtures must remain. as stated in your email above.

It makes sense that for safety reasons if the pins/straps are not fastened correctly then the bonnet will not lift completely endangering the driver and other competitors/officials etc, due to lack of vision by the driver. This does happen from time to time.

As a Technical Delegate officiating at a race meeting my actions are guided by the rules and my interpretation of those rules. Currently I have a fairly full agenda so if competitors do not wish to take simple actions to improve safety then so be it.

If I happen to make any Log Book notations for infringements on a Group N car for bonnet fastening components not fitted, then the secondary catch of the Production Car (being the hook) will be included. This is also applicable to forward opening bonnets.

Could the AHTCA consider consulting a Technical Delegate for their interpretation of the rule and move forward from that point. I am happy to assist when possible.

• Mr Nic van den Berg responded on the same date advising:

"...this note was circulated to all EOs by me as the secretary of the EO forum for possible discussion at the EO forum, which was established to discuss precisely what you have pointed to-interpretations.

I did not send it on behalf of the AHTCA.

It was not circulated because I have decided a rule.

Also, asking you and/or David before sending it is not appropriate.

I simply sent on something that has been sent out so that a discussion can occur. Input by you and David at that forum is entirely appropriate.

That is the function of a secretary of any group.

As mentioned to you during our chat, a Gold Scrutineer is above a technical delegate and an EO.

Frank Adamson made that clear at the first EO forum and that is recorded in the Minutes for that meeting.

Hence I thought it relevant to send the note to forum participants. Look forward to the discussion on this topic, perhaps on 17 May.

• Mr Bruce Richards responded on the same date advising: My apoligies if my recent email hit a nerve. The intention is that the rules are open interpretation and if a Tech Delegate and a Gold Scrutineer were to disagree on a particular item then the Stewards of the meeting would adjudicate according to the rules as they are written.

The Gold Scrutineer in Victoria May have his opinion however that is not final when the rules for Group N (in my opinion) read differently, depending on whether the General Regulations override the 5th Category Regs.

Just for your info, interesting isn't it. Even though it is a minor issue it is a good example of how the rules can be ambitious.

 Mr Nic van den Berg responded on the same date advising: It is interesting indeed! So is people's propensities to dig in on issues and blow them out of reasonable proportion! As I told you, this is a hobby horse of one person. I do hope the EO forum reaches a consensus that can be applied consistently across every State! I really do.

Mr Bruce Richards further responded on the same date advising:

 I hope we can work together to overcome some of the issues, I will try to help where I can and I hope that competitors understand that compliance is the difference between success or failure of the category.

David Twigg said to me recently and I agree.

The Biante breakaway from Group N a long time ago has developed into at situation that now exists where TCM has less than 20 cars (at a substantial cost) on the grid at PI and Group N has 50.

Competitors must understand that compliance is everything to survive.

Component Substitution

A Component Substitution application relating to the Datsun 1600 5 speed transmission was provided to the AHTCA on 24 April 2023 by the Chair of the HPBEC, with a request to:

distribute this Application and attachments to the various Group N clubs and their members for their information and comment. Could you please advise the HPBEC of replies and comments in the usual manner. Thank you The application was circulated to all AHTCA members and to the Eligibility Officer Mr Bruce Whitford on 24 April 2024.

The AHTCA will receive all comments by end May 2023 and will then prepare a response to the Chair of HPBEC.

EO Forum

The Members noted that the next EO forum will be held on 17 May 2023.

The Members also noted that a draft EO/TD checklist is being developed by AHTCA with the assistance of Mr Dean Bryant.

Minimum Weights

The Members noted that the AHTCA's request for an extension to the time limit of 31 May 2023 was granted on 5 May 2023 by the Chair of the HPBEC – AHTCA now has until 30 June 2023.

AHTCA is using this additional time to formulate our response. AHTCA members are actively pursuing responses from their Club members by 31 May 2023.

AHTCA is examining the HPBEC proposed weights and has produced a preliminary spreadsheet showing possible weights using the following methodology:

- Kerb weight
 - \circ $\;$ as found in the internet /or
 - as identified in vehicle workshop manuals
 - \circ $\;$ as sourced from the FIA historical database $\;$
- In the case of Kerb weight and vehicle workshop manual information, applying a 1% discount to that weight (that figure being used as it aligns closest with the numbers provided by HPBEC)

The Members agreed to give further attention to finalising a letter about this matter, which is to be finalised this week and issued to Motorsport Australia, the Historic Commission and the HPBEC.

Control Tyres

Focus on this matter is to be applied once the weights issue has been completed.

Motorsport Australia

The Members noted that a letter providing the CEO of Motorsport Australia with a status report of progress on matters brought to his attention in the AHTCA Chair's letter of 23 January 2033 and his response of 6 February 2023 was sent on 19 April 2023.

General Business

5 Year plan

The Members agreed that in coming months, AHTCA members turn our attention to:

- Developing a five-year plan for the AHTCA's activities with and for Historic Touring Cars, that plan including maters such as:
- as vehicles age and original parts become harder to source, proactive attention to developing a list of suitable substitute components through our own research, so as to be ready for a Component Substitution application to the HPBEC;
- as costs for components, vehicle preparation and event entry fees increase, researching and developing alternative solutions to attracting sponsorship for our category, including, but not restricted to markings on motor vehicles.



Dear Mr Arocca

I thought this would be a good opportunity to let you know how matters are progressing with AHTCA activities. You will recall our correspondence to you on 23 January 2023 and your response on 6 February 2023.

The Australian Historic Touring Cars Association AHTCA has seen considerable progress with a number of matters, the most significant being the finalisation of, and ongoing improvement to documentation about motor cars in our particular category, and the establishment of a forum for Historic Touring Cars Technical Delegates and Eligibility Officers.

You will remember that an exercise to improve the accuracy of the regulatory documents, the MA Specification Sheets, has been underway for many months. Mr Frank Adamson has provided a huge amount of help here, in checking and assisting in updating these sheets, and we now believe that they are in very good shape. Associated with those documents, the AHTCA has produced Reference Sheets for each motor vehicle and they have been published on the AHTCA website. I am sure that Mr Adamson would agree with the view that the documentation is now up-to-date and is readily available to all, through the Motorsport Australia website and through the AHTCA website, in the case of the Reference Sheets.

Our next challenge was to let competitors and officials know that this has happened and how these documents could be accessed. One important way to do this was to conduct a forum for Historic Touring Cars officials.

We worked again with Mr Adamson to develop the objectives of the forum and agree operating rules for these meetings, using Motorsport Australia guidelines.

Through that considerable help from Mr Frank Adamson, the on-line forum had its first meeting on 12 April 2023. It was chaired by Mr Adamson, who organised for the meeting to occur on-line through the use of Motorsport Australia's Teams licence. Eighteen people were invited to the forum. Fourteen people attended - twelve officials, Mr Adamson and Nic van den Berg, who conducted secretarial services for the forum. Those twelve officials were from all over Australia, the only exception being the Northern Territory.

Subsequent feedback was that all attendees saw this forum as being very important. They asked for the meetings to happen every month. They also suggested a chat room dedicated to those officials so that they could communicate within the group. That chat room has already been set up on the AHTCA website and is already being used.

The AHTCA sees this working relationship with Mr Adamson as fundamental to the success achieved to date and we appreciate Motorsport Australia making him available to us.
